Anchorage Convention Centers Audio/Visual Service Facility Access Fee Schedule

The Anchorage Convention Center welcomes client selection for audio/visual service companies. Imig Audio/Visual Services LLC has been selected as the "preferred" provider for a/v services within the facility. SMG of Alaska, Inc., the management company for the Centers does allow clients renting the facility to choose from local audio/visual service companies or accommodate a contractual obligation with a national audio/visual service company.

In any case, access to the Anchorage Convention Center communications rooms (a/v patch bays) is limited to our preferred a/v provider, Imig Audi/Visual Services (Imig A/V). Alternative audio/visual services companies must contact and coordinate move-in/sound/light systems patches to the facility "built-in" systems with Imig A/V. As part of the preferred status agreement with Imig, they have committed to maintaining an extensive inventory of state of the art equipment on site, to have trained a/v technicians available twenty-four/seven. In consideration of being granted the preferred status, Imig also pays a commission to the centers.

As of April 1, 2013 the Anchorage Convention Centers require a Facility Access Fee for all audio/visual service providers providing a/v services within the Centers. This access fee will be over and above the current existing "patch fees" paid to Imig and will be paid directly to the Centers. To better ensure the safety to the guests of the centers, the center's clients, the contractor's employees and SMG employees, requirements are that contractors submit proof of insurance, hang-plans with equipment specification and move/in – strike schedules, a minimum of two weeks prior to the event. By doing so, SMG can review and approve all plans, all materials used to attach/connect to the facility ceiling mounted hang points and built-in systems. The REVISED Facility Access Fee Schedule is as follows;
